# 2019 Marks Upper Dublin Township's Tricentennial

Our neighbors in Upper Dublin Township are celebrating the 300th anniversary of the township's incorporation this year. It became an official political unit in 1719.

The first celebratory event is Winterfest on Friday, February 1 from 7 to 9 p.m. with a chlii cookoff and sneak preview of Saturday's activities. On Saturday, February 2 from 4 to 8 p.m. there will be ice and light

shows, carriage rides, food trucks, and S'mores - followed by fireworks.

The Tricentennial Celebration continues throughout the year with a parade in May, dinner and dancing in June, Autofest in September, and a Fall Fest in November.

The following is from Wikipedia: Edward Tanner was granted land by William Penn in the Province of Pennsylvania and named it "Upper and Lower Dublin." Lower Dublin was incorporated into the City of Philadelphia following the passage of the Act of Consolidation in 1854. The "Upper" portion has continued to exist around the original survey for the laying out and naming of Susquehanna Road. Upper Dublin



Township was established in 1701, when William Penn ordered a survey of all townships in the Commonwealth. It was first settled in 1698, and incorporated in 1719.

As you know, Whitpain Township has been tremendously supportive of the 1895 Public School over the past several years, spending both time and significant amounts of money to preserve the structure of the building and to improve its safety and comfort. We are pleased to announce that we have just received our first financial support from Ambler Borough and Lower Gwynedd Township as well. We asked Ambler for \$750 to go towards new display materials in our redone museum and we asked Lower Gwynedd for \$6,200 to go towards the cost of airconditioning the building as a future phase of our renovation project. # **Loss of Lower Gwynedd Historic House**

"Gypsy Hill" was built in the very early 1900s by George Norris on Gypsy Hill Road. The 48 acres estate extended from Evans Road to Brushtown Road. Over the years, numerous houses were built along Gypsy Hill Road. For some years the mansion was occupied by the Brothers of Charity before becoming again a private residence. It was demolished this fall and will be replaced by a set of luxury townhouses.

According to Lower Gwynedd Township - A Pictorial Guide on Some of Its Older Buildings Gypsy Hill was named for the gypsies who used to camp in the area.

By chance, the recent donation of the flyers for the auction of property belonging to the Ingersoll family focuses on the house and land in Penllyn area. The Forest Hill development now covers much of the land.

As mentioned in a previous newsletter, there are several historic properties for sale along Penllyn Pike in Lower Gwynedd.



In the March newsletter we will feature an article by WVHS member and volunteer Yen Ho wrote for a Temple University course. She researched how properties come to be listed on the county, state, and national Register of Historic Places and why some important properties aren't listed as well as what being listed means.

An interesting example has been recently featured in the Philadelphia Inquirer - the Painted Bride Art Center's building in Philadelphia. The Philadlephia Historical Commission recently rejected an application to historically certify the landmark building following lengthy testimony from the public and advocates on both sides of the issue. Approval of the designation would have placed the building and all proposed changes to it - including demolition - under the historical commission's protective jurisdiction.

Those opposing the historical designation - largely the Art Center and its supporters - argued that certifying the building would significantly reduce the value of the property on the real estate market. This is a reminder that there can be varying and strongly held feelings about historic sites.
