Update on Wings' Field by Peg Johnston

I recently noticed lawn signs in Whitpain about the "rezoning of Wings Field". WVHS hosted a program about the historic Wings Field several years ago so I was curious. I asked WVHS member Rick Shorin about the issue. He is a member

of the Whitpain Township Planning Commission.

He explained that Advanced Wings, that manages the airport, is asking for a revision of its zoning plan. (A little background: Wings was established in 1930 [one the first airports in the country]; Whitpain's original zoning plan was drawn up in 1950. Wings is actually zoned as residential on the 1950 map and the airport is considered a "non-conforming use".) As an airport, it is under the jurisdiction of the FAA (operations in air above the airport, air traffic control, safety, some airport facilities), the state (operations on the ground, licenses, permits), and the township (use of the land).



Wings recently approached the Whitpain Planning Commission with an airport zoning plan that includes: that the airport would not become a commercial airport, that a substantial portion (minimum 60%) of the land would never be developed, that Wings would have the ability to put 5 houses near Narcissa Road, that Wings could replace hangars that are currently on site and add new hangars as approved by a Pennsylvania Supreme Court ruling, that there would be no change in runway length (currently 3800 feet), that an aviation museum could be built, and that they could open a private aviation club to serve those who use the airport.

Rick noted that newer, small planes have longer wings than older planes. This makes the planes more aerodynamic (efficient) and quieter than traditional planes, but they also require a bigger hangar. In recent years Wings has built noise barriers, land berms, and a parking lot for aircraft next to the runway to reduce noise levels. Increased noise is a concern of neighbors.

Rick also mentioned that, though it is *not* Wings' intention, under the current zoning (residential), up to 200 homes *could* be built on the 217 acres controlled by Wings Field.

To that end, they are currently favoring upgrading the steam heating system rather than replacing it.
