WVHS Officers and Whitpain Township Continue Plans for Moving the Skippack Pike Toll Booth: President Carol Kalos and Vice President Joe Langella met with Tom Farzetta, Whitpain Township's Director of Public Works, to discuss a location for the Toll Booth, once used by the Skippack Turnpike Company. It maintained the roadway from 1853 until 1901.

The township has generously agreed to create a site plan, prepare the structure's foundation, and possibly complete repairs and painting. Mr. Farzetta is pleased that his discussions with other township officials. Plans have moved quickly and smoothly. He says the township is thankful that WVHS has grabbed this opportunity to bring history to our citizens.

The Toll Booth has a door at each end and sliding windows on both sides, where the toll was collected. The doors are surrounded by a transom and sidelights with stained-glass panes, each about four-inches square. The old building's security (due partly to its stained-glass windows) is an issue. The township has chosen a site in Prophecy Park because this

location allows for parking and security lighting. Also, the structure will be assured a permanent home on township property. The next step is that township workers will visit the Toll Booth to take measurements and to consider its condition. WVHS is shopping for the best way to move this old structure.

The building once stood at the Chambers' House (earlier called the Black Horse Inn), diagonally across from the Blue Bell Inn. John Chambers, who now lives on a farm in Eagleville, donated what was originally Blue Bell's Dinner Bell and Toll Booth back to Whitpain Township! The Dinner Bell, pictured in January's *Valley Crier*, has already been moved.

Another Leak at the 1895 School's Heating System: On December 30, a pipe in the furnace room was discovered spraying water. The township called their repair service, which drained the steam system, attended to two leaks, and restarted the system on January 5. Fortunately, the heat was off during the December "heat wave" when temperatures remained warm. One worker explained that these pipes are cast iron, so the acid in the water inside the pipes eats through the pipes, and these leaks are inevitable.

Other Heating and Air Conditioning Woes at the 1895 School: WVHS can't save money fast enough! Although the museum's thermostat is set at 58 degrees, the last monthly oil bill totals over \$1,000 due to the increased price of oil. (Fifty-eight is the lowest recommended temperature to protect the old plaster.) In addition, the recent estimate for installing air conditioning was \$25,000, almost double the older estimate! (The board will look for additional estimates.)

New Homes Threaten Historic Lower Gwynedd Property: In 1710

Owen Evans, a Welsh Quaker, built a log cabin along Sumneytown Pike.

Over the years, he became a community leader, serving as a representative in Harrisburg for several terms. As he prospered, he enlarged his home and used a portion of it as a store. The old house, a barn (now a residence), and its 15-acre site are now for sale, and a builder has submitted preliminary plans for 10 new houses on the property.

Neighbors have expressed concerns about increased traffic, excess water run-off, the destruction of natural habitats, and, above all, the possible demolition of the historic and unprotected home. (A several-page article about Owen Evans appeared in the June 2022 edition of *The Quill.*)

Ambler Freight House: SEPTA has threatened to tear it down, but Ambler's Bernadette Dougherty, a former board member, has found a mover and has contacted SEPTA to get their permission to reset the structure to another location on SEPTA's property. The purpose of the move would be to position the 1800's Freight House away from a creek, which frequently floods. Recently, Emma Diehl from PA SHPO (the state's office for historic preservation) has been assisting Bernadette.

Ambler Storytellers are investigating creating a National Register Historic District for Ambler's charming downtown business area. An "application" was submitted in 2002, but the comments on the document were not addressed, and it remains incomplete. The group, with Mary Spross leading this project, is looking into modifying the original document to meet today's criteria. Mary and President Carol Kalos have met with April Franz, the local National Register reviewer, who was recommended by Megan McNish, the Eastern Region Community Preservation Coordinator for PA SHPO.

Please note that the Ambler Storytellers will not meet in February, and they will resume the Ambler Historic Walking Tours in April. The Storytellers report that since their Ambler Historic Walking Tours began in October, about 80 people, some of them WVHS members, have taken a tour.
